Dues Notices Being Mailed March 1, 2022

The annual dues notices will be mailed to companies in a separate mailing on March 1, 2022. We are hoping this method of sending dues notices, marked to the attention of the Treasurer, will make it easier for your organization to have this important piece of mail directed to the appropriate person. In the past, dues notices were included with this newsletter and many were lost, causing companies to miss the dues notice or request duplicate copies.

Dues for company members are \$10 per year. Companies who participate as one hundred percent companies are also receiving a roster of members currently on our rolls. Please check the membership rosters carefully. Each year we spend many hours attempting to correct oversights made by companies when verifying their roster. You must return the roster generated from our computer. We cannot accept membership lists generated from your computer.

Also included will be a company information sheet. **Please complete the company information sheet**. This information is not only very useful if we have questions related to your returned roster, but also comes in handy throughout the year should we, or another member, need to contact someone from your company. The individual officer information is not shared with anyone. Your general company address and phone number is all that would be provided to another member

Remember that your company and members' dues must be paid by July 31 to remain a member in good standing. You must be a member in good standing to be eligible to receive any association services, including the death benefit. If your officers have any questions or need assistance in completing the roster and dues payment information, please contact the office by the methods listed at the top of this newsletter. Our office staff will be most happy to assist. Clearing up misunderstandings at the beginning is always easier than clearing them up later.

Special Events This Month

Annual Association Workshop February 19, 2022, at 6 p.m. (one hour before regular meeting) at Point MarionVFC. The topic this year will be *Recuritment and Retention of Members for Fire Departments*. The workshop will be led by Tracie Young-Brungard, Recruitment and Retention Manager for the Pennsylvania Office of the State Fire Commissioner. She will be outlining best practices for recruitment and retention of members, along with highlighting the services available from her office to assist fire companies.

Association Purchases Trailer to Transport Convention Materials

In a motion make during a 2020 meeting, the association gave the executive officers permission to search for and purchase a utility trailer to store and transport various materials needed to operate our convention activities. The purchase was delayed by the pandemic. Vice President Ferrante took the lead on this project then in November of 2021, he located a used 2021 Homesteader Intrepid 12x7 utility trailer for sale. The association purchased the trailer for \$4,700 from a private owner. The title has been transferred to the association and Lower Burrell No. 3 has agreed to allow us to temporarily store the trailer on their property. Moving forward, the trailer will be taken to the site of the next convention once it is chosen.

The Board of Control, at it's December 2021 meeting, approved a proposal to have the trailer lettered with our web address and our logo placed on the sides and back of the trailer. That project was completed by 1Signs of New Kensington at a cost of \$1,185.00. The trailer is now ready for service.

Look for our trailer traversing the roads of Western Pennsylvania to bring the good news and work of the association to your community or a community near you.

Essay Contest Winners To Be Awarded Prizes at March 19 Banquet (R.S.V.P. Required)

The winners of the association's annual Fire Prevention Essay Contest will be presented their prizes at a special banquet/meeting held March 19, 2022, at the Allegheny Valley Volunteer Fire Company (Allegheny County) hall.
