126th Annual Convention Arnold, PA

Tuesday, August 13, 2019

The 126th Annual Convention of the Western PA Firemen® Association was called to order by President Wayne Harris and the 82th annual convention of the Ladies Auxiliary to the Western Pennsylvania Firemen® Association was called to order by President Jill Harris.

Opening prayer by Chaplain James Bowser followed by the presentation of colors by the color guard of Arnold Fire Department followed by the pledge of allegiance to the flag. President Harris introduced Ladies Auxiliary President Jill Harris who introduced the officers of the ladies auxiliary.

Local welcome was given by Christopher OøLeath of Arnold No. 2 Fire Dept. Response for the Western was given by Past President John Bem. Appointment of Sergeants at Arms: Martin Wetmore and Wilford Torrence.

Mayor Karen Peconni of Arnold was introduced and welcomed everyone to Arnold.

Kathy Snauffer, President of the Firemen® Association of the State of Pennsylvania, was introduced and made remarks concerning the work being done by that Association.

Motion by William Cornell and Pete Barnhart that all convention expenses, including banquet, be approved for payment. Motion carried.

Motion by William Cornell and Gene Walker that the Board approve the proposal concerning the dissolution of the Ladies Auxiliary as presented by Executive Director/Secretary Tedorski at yesterdayøs meeting. Motion carried.

Motion by Pete Barnhart and Wilford Torrence that the Board approve the proposal concerning the dissolution of the Camp Committee and Tent City as presented at last nightøs meeting. Motion carried.

Motion by Tom Schaeffer and Jim Norton that we transfer the Washington Mutual Fund into our Benjamin F. Edwards account. Motion carried.

Motion by Tim Gorencic and Wilford Torrence that the Executive Director/Secretary be authorized to purchase a single-axel trailer to store and transport the battle of the barrel and other convention-related equipment. Motion carried.

Christopher OøLeath commented on the work that Willie Weber and Tim Gorencic have done with the camp over the years and said that the Association owes them a vote of thanks. Motion by John Palcsey and William Cornell that both individuals be made life members of the Association as a gesture to show our appreciation. Motion carried. It was noted that Tim is already a life member being a past-president.

Willie Weber said that the Board should decide what will happen with the \$4,000 that was allocated to the convention host for the camp. After discussion, there was a motion by Jim Norton and Tim Gorencic that the total allocation be left at \$12,000 and that the convention guidelines be amended to determine how those funds are to be allocated. Motion carried.

Wilford Torrence questioned why we need to continue to have the February workshop/meeting at Pioneer Hose in Brackenridge every year. He suggested that we give other interested companies a chance to host.

Also, concerning meetings, there was a motion by Wilford Torrence and Don Ferrante that the May meeting be moved to the second Saturday of the month instead of the third to avoid the conflict with the Harrisburg Expo. Motion carried. This change to take effect with the May 2020 meeting with the Bylaw Committee agreeing to submit a proposed change to the bylaws to make the change permanent.

Reorganization

Past President Harris turned the meeting over to newly-elected President Larry Abel who conducted the annual reorganization of committees and other appointments.

It was reported that Natrona is still interested in the 2020 convention. Bruce Davis said that New Kensington is willing to move to next year if they need to. Natrona said that they are still interested, but they will not know for sure for a couple of weeks.

Motion by Gene Walker and Martin Wetmore that we adjourn. Motion carried. Meeting adjourned at 10:54 a.m.
